The Admission for Ph.D. Courses for Session 2020 are open in the following Departments. The last date of submission of application is 20.11.2020:

1. Anatomy, 2. Biochemistry, 3. Microbiology, 4. Community Medicine, 5. Clinical Psychology (Psychiatry Dept.), 6. Department of Orthopedics [Physiotherapy] and 7. Department of Orthopedics [Occupational Therapy], 8. Maxillofacial Surgery, 9. Integrated Implantology, 10. Orthodontics & Dentofacial Orthopaedics and 11. Paediatric & Preventive Dentistry.

The candidates who possess a recognized degree of M.Sc. Medical Anatomy, M.Sc. Medical Biochemistry, M.Sc. Medical Microbiology will be eligible for Ph.D. Medical Courses in the above respective subjects i.e. Anatomy, Biochemistry, Microbiology.

**SELECTION METHOD THROUGH ENTRANCE TEST (MCQ) AND INTERVIEWS.**

**Entrance Test will be held for eligible candidates on 26/11/2020 [Thursday] at sharp 9:30 A.M and interviews will be held at 2.00 P.M onwards i.e.,**

- a. A paper of MCQ of **General Nature**, intended to assess the teaching / research aptitude of the candidate **[35 Marks]**.
- b. Other paper of MCQ of **subject specific** for the concerned Ph.D. Course + **[35 Marks]**.
- c. **Interviews / Viva Voce of 30 Marks:** The candidates are required to present their **Research Interest / Area** through Power Point presentation before the Department Research Committee of the concerned department during their Interview / Viva Voce.
- d. Final selection will be based on the merit after combining the marks of entrance test [70%] and interview [30%], separately for each concerned department. **[Total = 100 Marks]**
- e. The candidates who have passed the CSIR-UGC NET – JRF examination or IRF examination by agencies like ICMR/ Department of Atomic Energy (DAE) etc. or selected already for JRF/ SRF/ Project fellows in research projects sanctioned by funding agencies to any of the faculty members of this Santosh Deemed to be University shall be **exempted from appearing for the Ph.D. entrance examination.**

1. **The Ph.D. course will start from 9<sup>th</sup> December 2020.**

2. Duration of the Course : 3 years (Minimum) and 6 years (Maximum)

3. Fellowships / Grant / Funding:

**After finalization of the admission process and scrutinization of JRF & SRF Fellowships eligibility, offer letter will be sent to the selected candidates only.**

4. The expenses if any, towards consumable items, shall be borne by the Ph. D student.

5. In case the student is selected for Ph.D. programme and no Fellowship / Grant from a recognized institution / college is available with him/her, in such case the student is required to bear all expenses for the same.
